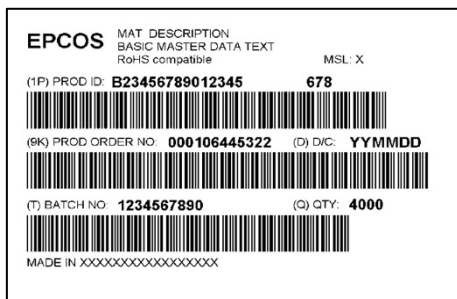
## Adjustment of barcode product labels and product marking

### 1. Barcode product labels

To comply with regulatory requirements TDK Electronics will extend the manufacturer identification by adding the headquarters address to barcode product labels.

In the course of this change the EPCOS logo will be replaced by the TDK logo.

## 2. Product marking

In line with the adjustment of barcode product labels TDK Electronics will also harmonize the product marking.

### 2.1. EPCOS logo versions on products

<p>2 Smaller products marked with the EPCOS logotype (positive or negative)</p>	 
<p>3 Small products marked with the EPCOS blocked-in graphic symbol (positive or negative); also outline version is valid</p>	  
<p>4 No product marking on very small products is also valid if the marking is technically not feasible or readable</p>	<p>No marking</p>

## 2.2. TDK logo versions on products

<p>1 Large products marked with the complete TDK product brand mark (positive or negative)</p>	 
<p>2 Smaller products marked only with the TDK logotype (positive or negative)</p>	 
<p>3 No product marking on very small products is also valid if the marking is technically not feasible or readable</p>	<p>No marking</p>

## 2.3. Manufacturer identification on products

If applicable the manufacturer identification with TDK Electronics headquarters address and the country of origin is applied to the product marking:
