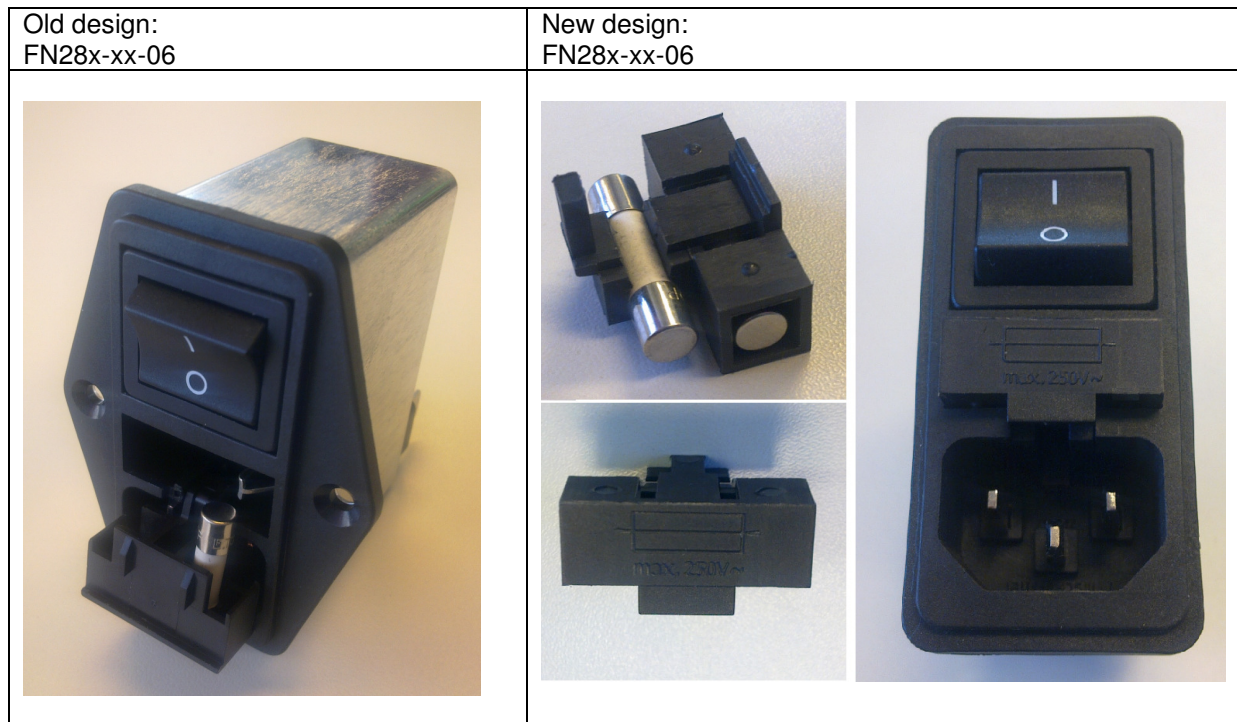
### Identification:

Outside there is no visual difference at the fuse holder.

When pulled out the fuse is now located horizontal across the power entry module instead inward-looking like before (see pictures).

During a transition period both versions may be delivered from stock.
