WHAT:

For the product family L638xED in SO 8 package, assembled in ST Muar and currently tested in ST Muar (Malaysia), we are going to use ST Shenzhen (China) as additional test and finishing plant. The new testing site is not expected to result in any impact on form, fit, function, quality or reliability of the product.

WHY:

To better utilize ST's assets.

HOW:

Test platform, test program and flow are unchanged. The same test board will be used in Shenzhen. Qualification criteria are based on the yield comparison between Muar and Shenzhen during ramp-up in the additional plant.

WHEN:

New test and finishing plant from August, 2012.

The testing in Shenzhen will be identified by a new internal part number, as shown below:
