3 Detailed description of change

Some old and new label have been added as an example for visualization.

Product identification section: To improve readability, all the information concerning product identification in this group is clustered. Furthermore, some of the content/ text of the label is subjected to following changes (see highlighted red areas on the labels of the following page):

- Product Type: Not changed.
- Configuration Code: Has been added.
- Part Description: Has been added.
