### **Revision Description:**

### **Description Of Change**

ADI is transferring to subcontractor Amkor Philippines for the assembly of Punched LFCSP products. The package outline dimensions and BOM of each product will be maintained.

#### Reason For Change

ADI is transferring to Amkor Philippines due to the closure of this Amkor Korea factory line at the end of December 2015.

ADI's assembly subcontractors manufacture products using Analog Devices specified manufacturing flows, materials, process controls and monitors, ensuring the same level of quality and reliability on products they receive from the new site.

### Impact of the change (positive or negative) on fit, form, function & reliability

The transfer will have no impact on the form, fit, function and reliability of the devices.
