Additional production line in India for EPCOS PFC capacitors

In order to expand the production for power factor correction (PFC) capacitors and improve delivery times, an additional production line will be introduced in Nashik, India, for the below listed EPCOS PFC capacitors. Until now these products are manufactured only in Bawal, India. The first products from the new line will be shipped starting in January 2017.
