GTCO has detected that the ST Outer Label Origin Country is extracted from SAP PLM while Origin Country on ST Inner Label is extracted from Traceability Code and computed wrongly for certain products (Majority of products are computed correctly)

Alignment of Origin Country showing on both ST Inner Label and ST Outer Label will be implemented to correct a misalignment showing 2 different Origin Country.

As this PCI is initiated to rectify an error and this has to be effective as soon as possible, the following requirements for Risk Assessment and Qualification are not conducted as this is a Quality Improvement.

Content Information of Origin Country for ST Inner Labels IS NOT aligned with ST Outer Labels, Shipping Documents, Invoices


Root Cause:

Inner Labels reporting MES(Factory Works)/Traceability Code data

Current Practices

- GTCO has proposed the following text
- ST has reviewed the "Assembled in" information that is reported on the Inner Labels to align it with the information printed on the Outer Labels, Shipping documents and Invoices.
- As a result you, ST Customer, might see a change in the "Assembled" in" country information printed on Inner Labels which is simply the result of an updated computation based on principle of substantial transformation (recognized by EU, US and WCO), but it does NOT imply any change in the production manufacturing flow of the product itself.
