Subject: PCN 126.a – EOL notice

Description: As part of our continuous quality improvement process LEDiL is planning to obsolete four-screw versions of 2X2MX family in order to remove possible risk of compromised ingress protection in cases where the lens is used close or over its maximum temperature limits.

LEDiL does not recommend four-screw versions to be used in new designs anymore, and will upgrade 2X2MX product family to use eight screws as we already do in 2X2MXS products.

All current beams will be available in eight-screw versions later this year and all new beams will come with eight screws by default.

This change will cause minor changes into recommended PCB design, as we need to reduce PCB outline dimensions 1,5 mm from each side to make room for additional screw towers and the modified gasket. You can find new REV2 design file as an attachment. The LED layout will remain unchanged.

Time line: Eight-screw versions for existing 2X2MX beams are targeted to be available in November 2016, and LEDiL offers last buy opportunity for the four-screw versions until November 30th 2017.
