Eaton would like to bring to your attention the upcoming legislative changes affecting Eaton's Bussmann series JKS fuse links.

As of July 22<sup>nd</sup> 2019, the scope of the RoHS-Directive 2011/65/EU will be extended to all Electrical and Electronic Equipment (EEE) which were not in the previous RoHS directive (see details page 2).

Our JKS fuse links will be made obsolete and be replaced by the LPJ fuse links, see cross reference on page 3.

### What is the updated RoHS directive?

The scope of the RoHS directive 2011/65/EU will be extended to all Electrical and Electronic Equipment (EEE) which were not in the previous RoHS directive.

### When does the updated RoHS directive come into place?

On the 22<sup>nd</sup> July 2019.

### What is the impact on Eaton's Bussmann series fuse links?

If some fuse links, made of materials containing restricted substances, are above the limits given in the new directive they will no longer be compliant. Their CE markings will be removed and therefore will no longer be allowed to be sold or imported in Europe and associated EEA-Countries from the 22<sup>nd</sup> July 2019 onwards.

### Which fuse links are affected?

Fuse links manufactured after 22<sup>nd</sup> July 2019, **which contains restricted substances above the limits given in the new directive**, will be affected.

### What about fuse links manufactured before 22<sup>nd</sup> July 2019?

Fuse links manufactured prior to this date are exempt and will retain CE conformity as originally directed on the date of manufacture.

### What about fuse links purchased before 22<sup>nd</sup> July 2019?

Fuse links purchased before 22<sup>nd</sup> July 2019 are exempt from this legislative change and allowed for sale.
