

Honeywell Announces Improvements to the 20PC (24PC, 26PC) & Force (FSS & FSG) Product Families

Effective immediately, Honeywell Sensing & Internet of Things (SIOT) will begin to introduce improvements to the 20PC Unamplified Board Mount Pressure product family (including 24PC & 26PC series) and the Force Sensor product family (FSS and FSG Series). The improvements are described below:



- Alternative seal source: Conductive seal will be procured from a second source.
- Die edge isolation: Improved isolation layer around the edge of the sense die.

These improve the product robustness for a wider range of applications. The introduction of the new seal and the improved die isolation will be implemented as a running change. There will be no alterations to the product catalog listings or data sheet specification.

For traceability purpose, Honeywell will make the following changes to the date code marking on the product:

Current Date Code Configuration	YYMMJ	End letter "J"
Date Code configuration after implementing the new conductive seal	YYMMS	End letter "S"
Date Code configuration after implementing the new conductive seal and the improved isolation layer	YYMMK	End letter "K"
